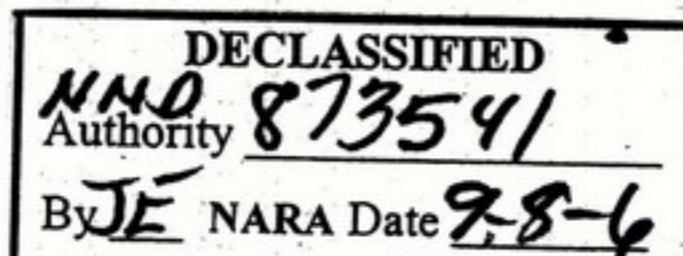
TARGET SURVEILLANCE:

- A. BTRY A, 6/27 ARTY EXPENDED 10 RDS 8" ON ENEMY IN THE OPEN AT GRID XT 4889 (4 KILOMETERS NORTHWEST OF FSB BURKETT). AN AO (NILES 04) ADJUSTED THE MISSION AND REPORTED ~~NO SIGNIFICANT SURVEILLANCE~~. *TRAILS EXPOSED AND FIGHTING POSITIONS DAMAGED*
- B. BTRY C, 6/27 ARTY EXPENDED 3 RDS 175 ON ENEMY IN THE OPEN AT GRID YU 918661 (10 KILOMETERS NORTHWEST OF PHUOC VINH). AN AO ADJUSTED THE MISSION AND REPORTED ~~NO SIGNIFICANT~~ *TRAILS EXPOSED* SURVEILLANCE:
- C. BTRY C, 6/27 ARTY EXPENDED 20 RDS 175 ON A BUNKER COMPLEX AT GRID YU 112608 (10-11 KILOMETERS NORTHEAST OF PHUOC VINH). AN AO ADJUSTED THE MISSION AND REPORTED 6 BUNKERS DESTROYED.

- B. 21 APRIL 70, XO, 6/27 ARTY DEPARTED QUAN LOI ENROUTE TO SONG BE AND THEN RETURNED TO THIS LOCATION. XO RETURNED TO THIS LOCATION AT 1630 HOURS.
- C. 21 APRIL 70, CG, II FFORCEV ARTY MADE A COMMAND INSPECTION VISIT AT BTRY B, 6/27 ARTY (SONG BE) FROM 1200-1235 HOURS. CG COMMENTED ON NEEDING MORE POLICING OF AREA AND ALSO STATED THAT EXPOSED WOOD BRACING ON POWDER SHOULD BE COVERED. ~~CORRECTIVE ACTION WAS INITIATED~~

- 21 APRIL 70, CG, II FFORCEV ARTY MADE A COMMAND INSPECTION VISIT TO BTRY A, 6/27 ARTY (FSB BURKETT) FROM 1430-1445 HOURS. CG WAS ESCORTED BY LLT PASSAGE, AXO, BTRY A, 6/27 ARTY. CG WAS CONCERNED WITH CONDUCT OF THE BATTERY DURING LAST NIGHTS ACTION. THERE WERE NO CORRECTIVE ACTION REQUIRED.
- E. 21 APRIL 70, CG, II FFORCEV ARTY MADE A COMMAND INSPECTION VISIT TO BTRY B, 6/27 ARTY (FSB COMPTON) FROM 1310-1330 HOURS. CG WAS ESCORTED BY CPT BUHNMANN, CO BTRY B, 6/27 ARTY. CG BRIEFED TROOPS ON GROUND ATTACK PROCEDURES AND STATED THAT AREA LOOKED ~~GOOD~~ ^{STRONG} ENOUGH FOR A GROUND ATTACK.
- F. 210505 APRIL 70, FSB BURKETT RECEIVED UNKNOWN RDS RPG 'S IMPACTING OUTSIDE THE PERIMETER OF BTRY A, 6/27 ARTY. THERE WERE ~~TWO~~ ^{FOUR} CASUALTIES AND ONE WATER TRAILER DAMAGED. COUNTER BATTERY WAS FIRED. *17 Round ICM FIRED AT close RANGE.*
- G. 202145 APRIL 70, BTRY B, 6/27 ARTY (SONG BE) RECEIVED 11 RDS 122MM ROCKETS IMPACTING AROUND ASP. THERE WERE 1 CASUALTIES REPORTED AND NO DAMAGE. COUNTER BATTERY WAS ~~FIRED~~ FIRED.
- H. 202150 APRIL 70, BTRY B, 6/27 ARTY (FSB COMPTON) RECEIVED 20 MORTAR RDS IMPACTING OUTSIDE BTRY PERIMETER. THERE WERE NO CASUALTIES OR DAMAGE REPORTED. COUNTER BATTERY WAS FIRED.

- B. 22 APRIL 70, COL HEARIN, DC, II FFORCEV MADE A COMMAND INSPECTION VISIT AT BTRY B, 6/27 ARTY AT FSB COMPTON FROM 1310 HOURS TO 1330 HOURS. DC WAS ESCORTED BY LLT BLACK, XO, BTRY B, 6/27 ARTY. DC COMMENTED THAT POLICE OF FDC AND AREA NEEDED IMPROVING AND ALSO STATED THAT THE AREA LOOKED REAL GOOD.
